INVESTMENT OBJECTIVE

The Fund's investment objective is long-term capital growth.

FOCUS ON QUALITY

Managed by an experienced team with a long history of employing the quality investment style, the Fund invests primarily in equity securities of non-U.S. companies that the portfolio managers believe have enduring competitive advantages and strong international brands or franchises, along with durable business models. Those companies typically have dominant market positions in stable, growing industries; low sensitivity to economic and market cycles; healthy balance sheets and low capital intensity; and sustainable cash generation and effective capital allocation.

A HIGH-QUALITY INTERNATIONAL PORTFOLIO

The Fund provides investors access to high-quality, international companies that seek free cash flow growth. The Fund provides exposure to the quality investment factor in international markets, without a bias toward more traditional factors such as growth and value. The concentrated, high-conviction portfolio consists of 25 to 40 quality companies.

The P/E Ratio of a stock is calculated by dividing the current price by forecasted 12-month earnings per share. The P/B Ratio of a stock is calculated by dividing the current price by book value per share. Return on Equity (ROE) is net income divided by net worth. R-squared (R2) is the percentage of the Fund's three-year return that is explained by movements in its benchmark index. Alpha is a measure of the Fund's expected performance versus the benchmark, adjusted for relative risk. Beta is a measure of the Fund's volatility versus the benchmark. Sharpe Ratio is a measure of the Fund's return per unit of total risk. Standard Deviation is a measure of the historical volatility of the Fund's returns.

For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating™ based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly performance (including the effects of sales charges, loads and redemption fees), placing more emphasis on downward variations and rewarding consistent performance. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. (Each share class is counted as a fraction of one fund within the scale and rated separately, which may cause slight variations in the distribution percentages.) The Overall Morningstar Rating for a fund is derived from a weighted average of performance figures associated with its three-, five- and 10-year (if applicable) Morningstar Rating metrics. In the U.S.-domiciled Foreign Large Growth category, the American Beacon Ninety One International Franchise Fund (R5 Class) was rated 2 stars out of 359 funds overall.
