INVESTMENT OBJECTIVE

A multi-manager Fund seeking long-term capital appreciation and current income primarily through investments in large market capitalization U.S. stocks.

STRENGTH IN DIVERSIFICATION

The multi-manager approach brings diversification to the Fund, potentially mitigating loss.

- The Fund's bottom-up portfolio construction is well diversified at the security, industry and stock levels.
- The Fund's assets may also include preferred stocks, convertible securities, American Depositary Receipts and foreign stocks traded on U.S. exchanges.

TEAM OF MANAGERS

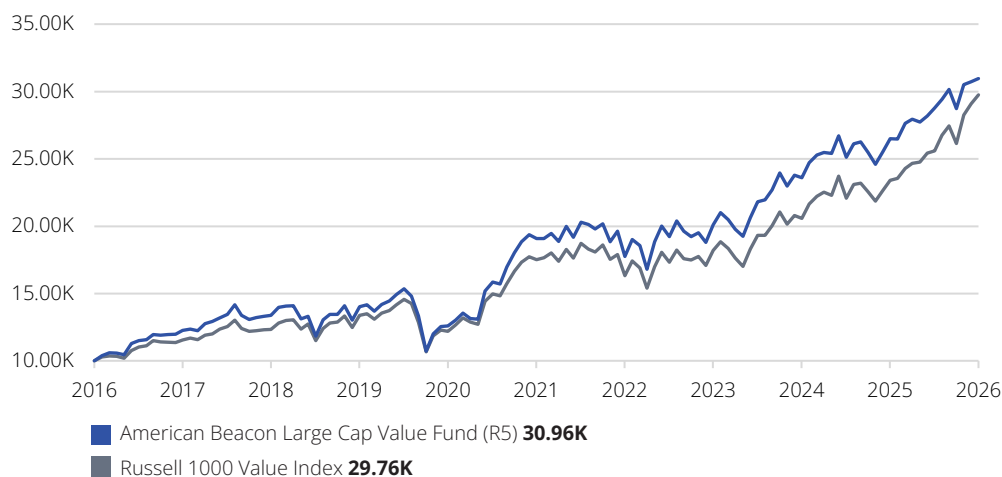
The Fund is sub-advised by complementary asset managers that select stocks as follows:

Barrow: Bottom-up analysis, with P/E and P/B ratios below the market and dividend yield above the market.

H&W: Sustainable cash flows and strong balance sheets, undervalued relative to tangible assets and long-term normal earnings power.

MFS: Undervalued, high-quality companies with sustainable, durable franchises, significant free cash flow and strong management teams.

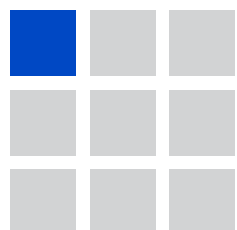

The P/E Ratio of a stock is calculated by dividing the current price by forecasted 12-month earnings per share. The P/B Ratio of a stock is calculated by dividing the current price by book value per share. Return on Equity (ROE) is net income divided by net worth. R-squared (R2) is the percentage of the

Fund's three-year return that is explained by movements in its benchmark index. Alpha is a measure of the Fund's expected performance versus the benchmark, adjusted for relative risk. Beta is a measure of the Fund's volatility versus the benchmark. Sharpe Ratio is a measure of the Fund's return per unit of total risk. Standard Deviation is a measure of the historical volatility of the Fund's returns.

The Morningstar Style Box™ reveals a fund's current investment strategy. For equity funds, the vertical axis is based on market capitalization of the Fund's holdings (large, mid and small); the horizontal axis shows growth and valuation analysis of the Fund's holdings (value, blend and growth).

For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating™ based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly performance (including the effects of sales charges, loads and redemption fees), placing more emphasis on downward variations and rewarding consistent performance. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. (Each share class is counted as a fraction of one fund within the scale and rated separately, which may cause slight variations in the distribution percentages.) In the U.S.- domiciled Large Value category, the American Beacon Large Cap Value Fund (R5 Class) was rated 3 stars out of 1,054 funds overall. The fund was rated 3 stars out of 1,054 funds; 3 stars out of 991 funds and 3 stars out of 830 funds for the three-, five- and 10-year periods, respectively.
