The Fund's investment objectives are to seek a positive return based on a combination of income and, secondarily, capital growth.

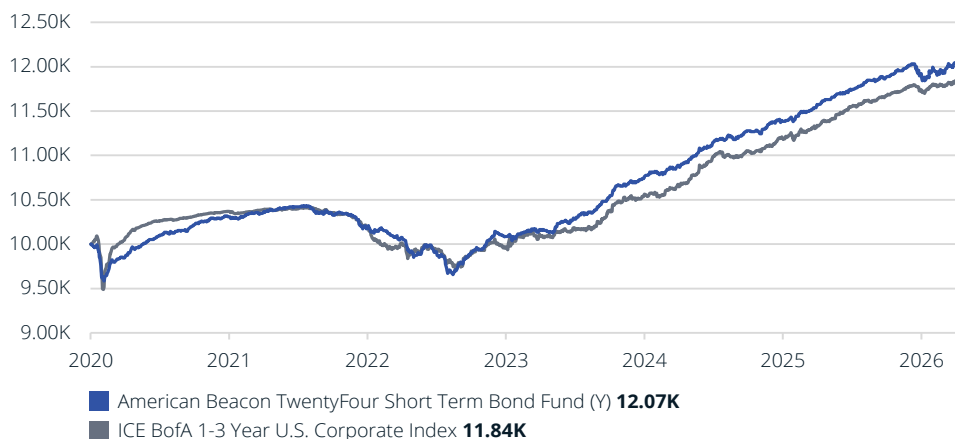
