Performance Commentary for the Quarter Ended June 30, 2026

Note: The comments below focus on the absolute contribution to the Fund's return and are not relative to the index. Source of attribution return data is Man AHL. Returns are gross of fees with the exception of Fund return, which is net of fees.

- **Equities** were the largest contributor with positions in the S&P 500 and NASDAQ 100 indices driving gains. Asian and European indices added further, while positions in the H-Shares and Hang Seng indices weighed on performance.
- **Inflation**-sensitive assets detracted, as gains from inflation-linked bonds, principally from U.S. positions, were outpaced by losses from commodities with prices declining across the energy and metals markets.
- **Credit** was accretive as high-yield and investment-grade spreads tightened in Europe and the U.S.
- **Fixed Income** was profitable with gains distributed across regions. Positions in 10-year U.K. gilts and Italian bonds were the top performers, while U.S. Treasuries were more muted.
- **Exposure** increased as the overlays de-activated. The correlation overlay de-activated near the end of the quarter, while the volatility overlay was inactive from April. The momentum overlay was active across bonds, commodities and equities.
