Security selection – positive / Sector allocation – positive

- Security selection in the Health Care and Communication Services sectors contributed during the quarter. Conversely, security selection in the Information Technology and Industrials sectors detracted.
- From a sector allocation perspective, null weights to the Energy and Consumer Staples sectors contributed. Conversely, an overweight allocation to the Health Care sector and an underweight allocation to the Information Technology sector contributed.
