Performance Commentary for the Quarter Ended June 30, 2026 (Attribution vs. Russell 1000 Growth Index¹)

Sector allocation – positive / Security selection – positive

- Security selection in the Information Technology and Communication Services sectors contributed positively to relative performance. Conversely, security selection in the Health Care sector and Industrials sector detracted from relative performance.
- From a sector allocation perspective, an underweight allocation to the Consumer Discretionary sector and an overweight allocation to the Information Technology sector contributed positively to relative performance. Conversely, an overweight allocation to the Health Care sector detracted from performance.
