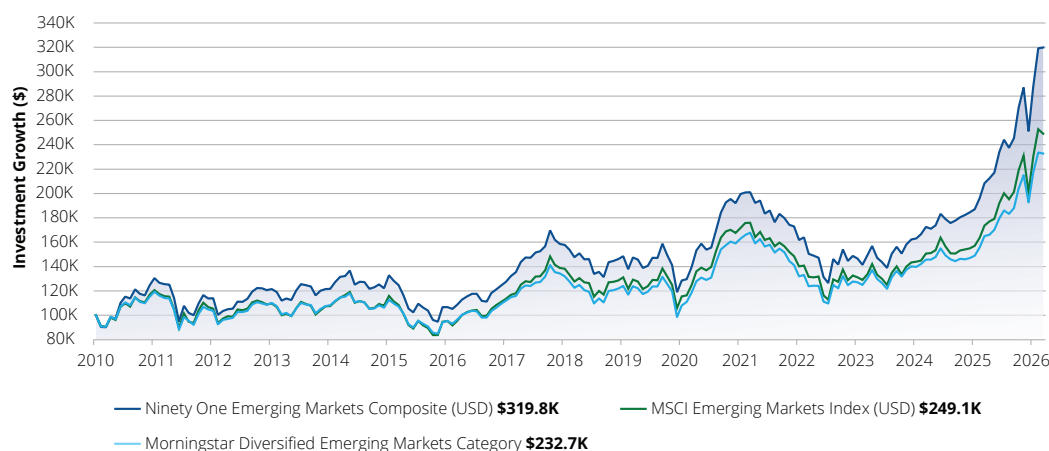

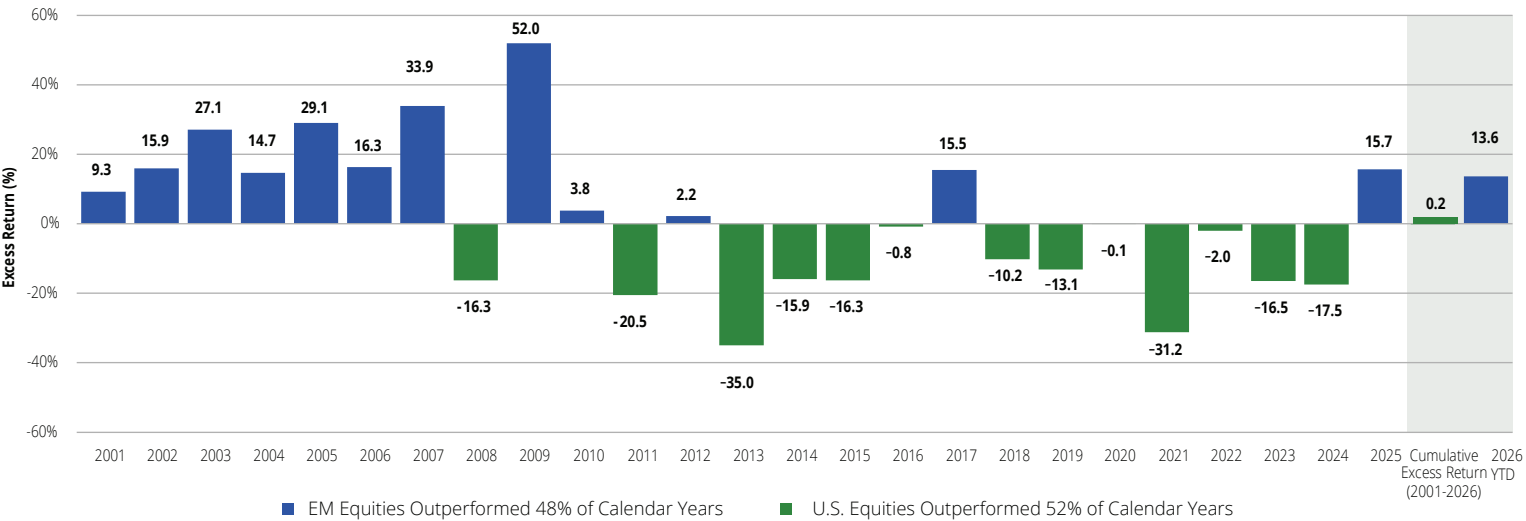

A Fresh Look at Emerging Markets: Since its inception in 2001, the MSCI Emerging Markets Index has generated a return comparable to the S&P 500 Index, though relative outperformance between the two has alternated in multi-year cycles. Emerging markets may now be at an inflection point, supported by improving fundamentals, attractive valuations, and a supportive macroeconomic backdrop. In 2025, emerging market equities surged after years of underperformance, signaling renewed investor interest and a possible performance inflection point for the region.

The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. (Each share class is counted as a fraction of one fund within the scale and rated separately, which may cause slight variations in the distribution percentages.) The Overall Morningstar Rating for a fund is derived from a weighted average of performance figures associated with its three-, five- and 10-year (if applicable) Morningstar Rating metrics. In the U.S.-domiciled Diversified Emerging Markets category, the **American Beacon Ninety One Emerging Markets Equity Fund (Y Class)** was rated 4 stars out of 688 funds overall.
