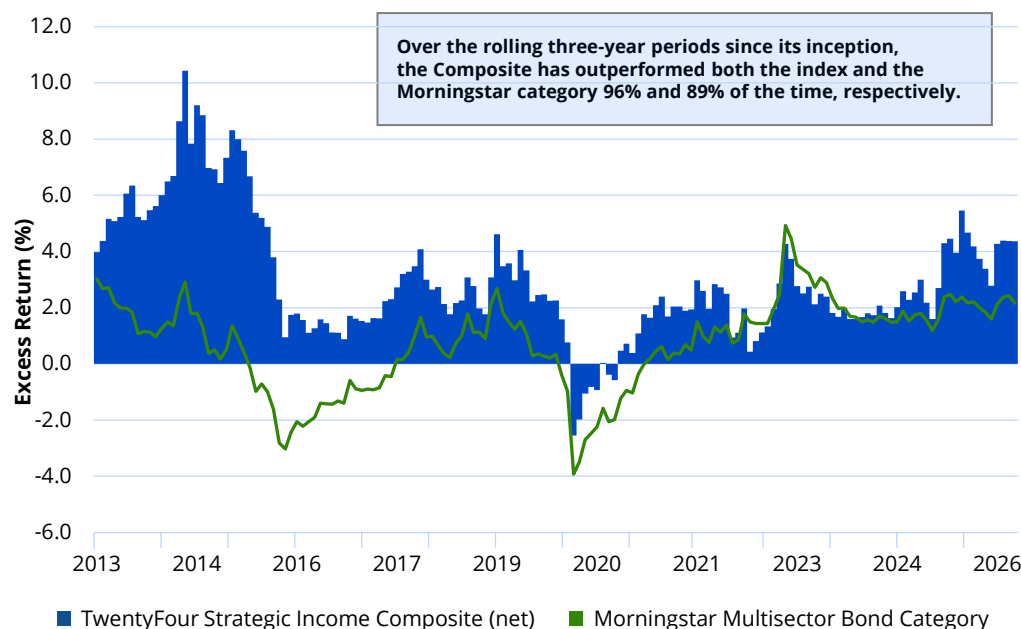

Seeking Consistent Outperformance

Since its inception, the TwentyFour Strategic Income Composite (net) has produced positive excess returns in 150 out of 157 rolling three-year periods versus the Bloomberg Global-Aggregate Total Return Index Value Hedged USD.

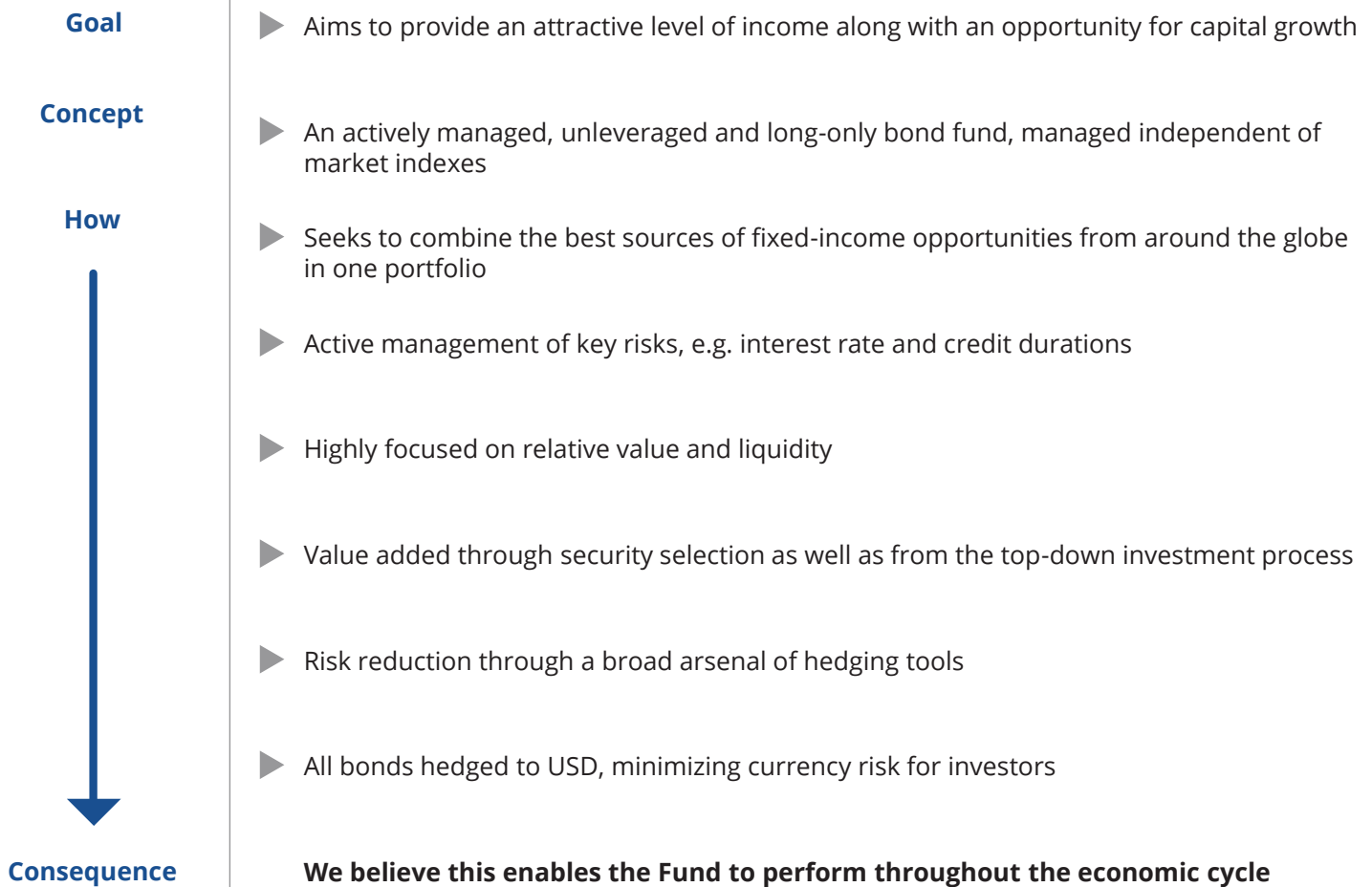

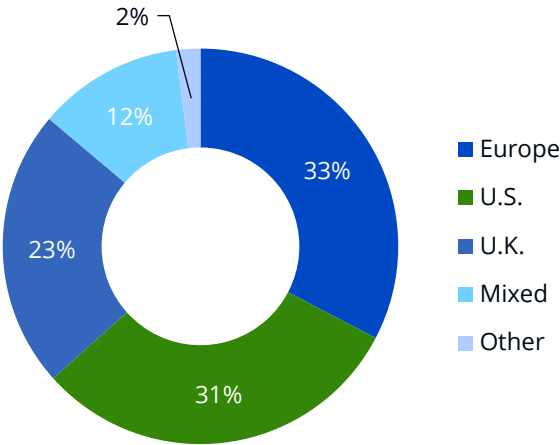

Geographic Breakdown

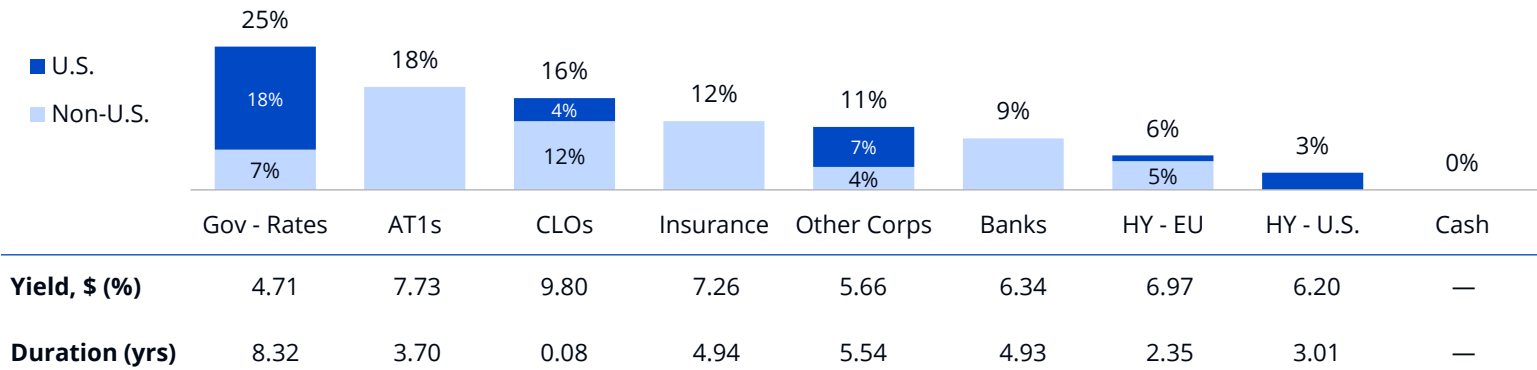

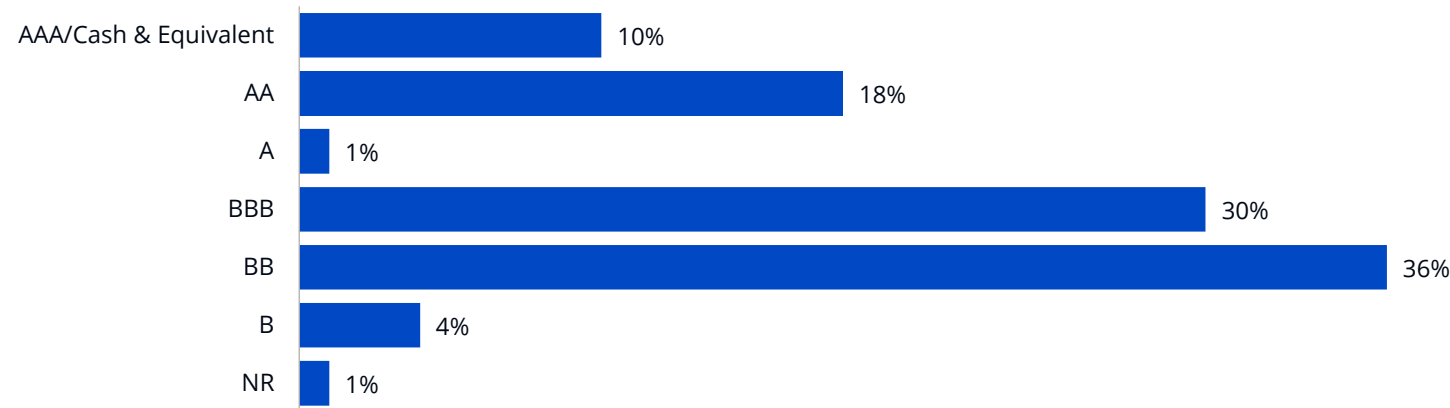

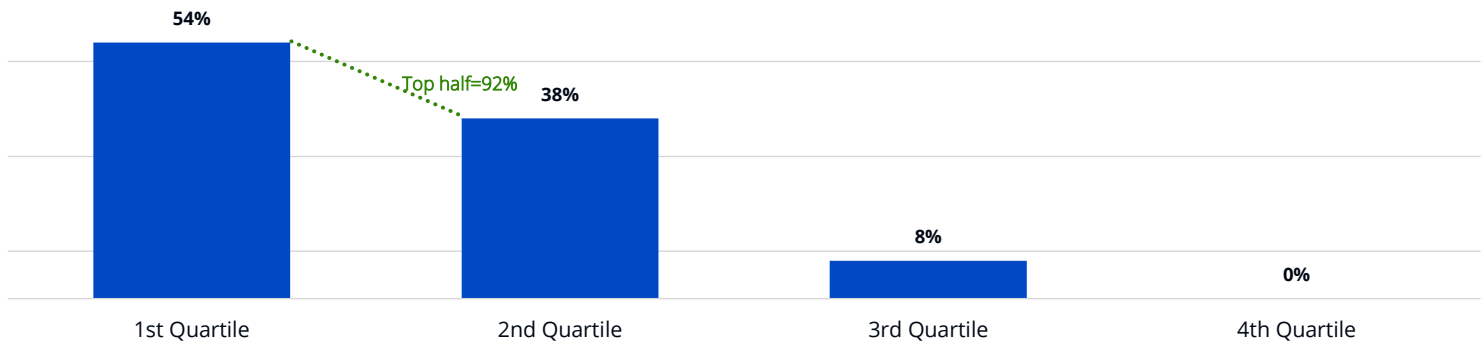
Rating Breakdown
